Preparation of Manuscripts for Research Papers, Brief Reports, Literature Reviews & Special Articles

The types of articles that can be submitted for publication to the Philippine Journal of Psychiatry include the following: research reports, brief reports, literature reviews, special articles, case reports, commentaries, book reviews, monographs, letters and others.

RESEARCH REPORTS

The manuscript must be:

- sent as a Microsoft Word document (.doc or .docx)
- written in English or Filipino
- in Times New Roman font, font size 11, single-spaced
- in US Letter sized paper (21.59cm x 27.94cm, or 8.5in x 11in) with 1" margins
- with page numbers, placed at the lower right hand corner of each page, beginning with the title page.

The manuscript should be arranged as the ff:

- 1) Title
- 2) Structured Abstract
- 3) Text
- 4) Acknowledgments
- 5) References
- 6) Tables
- 7) Appendices

Enclose disclosure and transfer of copyright duly signed by all the authors and keep copies of everything submitted. The manuscript must be accompanied by copies of any permission to reproduce published material, to use illustrations or report information about identifiable people or to name people for their contributions. Manuscripts may be sent through email to the PPA office, the Editor in Chief and/or the Manuscript Editor.

I. The **Title Page** should include a concise and informative title, author's name with highest academic degree as well as the name of institution to which work can be attributed or where research study was conducted. The title should include the study design especially for randomized controlled trials i.e. any research project that prospectively assigns human subjects to intervention or concurrent comparison or control groups to study the cause and effect relationship between a medical intervention and a health outcome.

Include the name, telephone & cell phone numbers, mailing & email addresses of the author responsible for correspondence about the manuscript and the author to whom requests for reprints should b addressed.

Sources of support in the form of grants, equipment, drugs or all these should also be included. If paper was presented at a national or international meeting, full details of the meetings should be stated such as title, place and date.

II. The structured ABSTRACT should include:

OBJECTIVES- purpose of the study or research question;

METHODOLOGY – study design, selection process, setting, subjects, observational and analytical methods, intervention(s) if any and main outcome measure(s);

RESULTS– main findings of research in relation to objectives stated and give the statistical significance of observations; &

CONCLUSION– primary conclusions with emphasis on new and important aspects of the study or observations and funding sources. The abstract should not exceed 250 words and list up to 5 key words under which article will be indexed.

III. The Text should consist of Introduction, Methods, Results and Discussion.

A. The **INTRODUCTION** should provide the context and rationale or the study i.e. nature of the problem and its significance. State the specific purpose or research objectives of or hypothesis being tested by the study. The research objective may be stated as a question.

B. The **METHODOLOGY** section should describe how and why the study was done in a particular way in as much detail about the Study Design and with enough Technical Information that would allow others to reproduce the results. Methods for Selection of study population i.e. inclusion & exclusion criteria, data collection, and data analysis procedure should be concisely yet easily understandable to the readers. Description of Study Participants should include the Source Population, explain relevance of inclusion / exclusion criteria and demographic variables chosen e.g. why choose to study only women from 40- 60 years old. How variables were measured may also be important to specify. Describe the Statistical Methods with enough detail to enable knowledgeable reader with access to the original data to verify the reported results. When possible, quantify findings and present them with appropriate indicators of measurement error or uncertainty i.e. confidence intervals. Define statistical terms, abbreviations and symbols used as well as specify the computer software used. Ethical **Considerations** for the protection of human subjects and animals in the research should be indicated as when informed consent was obtained and if the procedures followed were in accordance with the ethical standards of the responsible committee on human experimentation (institutional and national) as well as with the Helsinki Declaration of 1975 as revised in 2008. Do not use patient's names, initials, or hospital numbers, especially in illustrative material.

C. The **RESULTS** should report only the findings related directly to the research objectives. Give numeric results as absolute numbers and as percentages as well as how they were statistically analyzed. Use metric or S.I. units of measurement and specify all units of measurement clearly. Use only standard abbreviations. Include *Tables & Figures* only if they present relevant numerical data more clearly than could be done in the text. Do not repeat all the data in tables, graphs or illustrations in the text, where only the most important observations are summarized. Label tables & figures appropriately and number consecutively in order of their first citation in the text using Arabic numerals. Be sure that each table and figure is cited in the text otherwise don't include it.

Cell alignment of **Tables** should be to top left, single spaced or auto-fitted to contents of cell with all grid lines visible. Place a heading for each table column and brief title for each table above the table. Explanation or discussion of results in the table should be placed before the Table and place Table number referred to after paragraph where it is mentioned e.g. (Table 1). *Figures* should be as self-explanatory as possible. Figures accepted for publication must be clear, uncluttered, and two-dimensional. Figure number and title should be placed below the figure. Explanations for the Figures are placed after the Figure and indicate in parenthesis which Figure was being described e.g. (Figure 2) For x-ray films, scans and other diagnostic images as well as pictures of pathology specimens or photomicrographs, send sharp, glossy, black and white or color photographic prints 5 x 7 inches or 127 x 173 mm in camera ready form. The names of the authors should be written at the back of each plate. **Photomicrographs** should have internal scale markers. Titles and detailed explanations should be placed in the legends not on the illustrations themselves. Explain the internal scale and identify the

method of staining in photomicrographs. When symbols, arrows, numbers or letters are used to identify parts of the illustrations, identify and explain each one clearly in the legend.

Please list on a separate page, values for the data points shown on graphs, in case the reviewers/ editors of the journal has to recreate some figures. When reporting statistically significant results, always report the observed test statistic value, degrees of freedom, probability level, and for t & F tests, whether repeated measures were used.

Supplementary materials and technical detail can be placed in an **APPENDIX** where they will be accessible but do not interrupt the flow of the text. Appendices are numbered in sequence of how they are referred to in the text e.g. (Appendix 3). Checklists and questionnaires are generally not published.

D. The **DISCUSSION** should emphasize the new and important aspects of the study and the conclusions that follow from them. Link the conclusions with the goals of the study but avoid unqualified statement or conclusions not supported by your data. Recommendations when appropriate may be included. Do not repeat study results in the discussion but rather give explanations for the findings, compare and contrast the results with other relevant studies and state the limitations of the study. Explore the implications of the findings for future research and for clinical practice.

E. The **ACKNOWLEDGMENTS**: Disclosure statements of sponsoring body may be required for studies promoting products or services described in the paper. One or more statements should specify contributions that need acknowledging but do not justify authorship such as emotional, financial, material or technical support. The corresponding author should submit the written permission to be acknowledged from all acknowledged individuals before printing.

F. REFERENCES: Only relevant references, preferably from original researches should be cited in the text and listed according to their order of appearance in the text using Arabic numerals in parenthesis or superscript. Limit these to material that has already been published, accepted for publication or presented at a major national meeting.

Citations of material in press must include journal or publisher's name followed by "in press" or forthcoming". If unpublished material is cited indicate source and year in parenthesis in the text or written as a footnote.

Avoid citing a "personal communication" unless it provides essential information unavailable from a public source, in which case the name of the person and date of communication should be cited in parentheses in the text. For scientific articles, obtain written permission and confirmation of accuracy from the source of a personal communication.

Avoid using abstracts as references. Accuracy of the citation is the author's responsibility. Abbreviations of journal names should conform to those used in Index Medicus.

CASE REPORTS, COMMENTARIES, BOOK REVIEWS, MONOGRAPHS & LETTERS TO THE EDITOR:

The manuscript must be:

- sent as a Microsoft Word document (.doc or .docx)
- written in English or Filipino
- in Times New Roman font, font size 11, single-spaced
- in US Letter sized paper (21.59cm x 27.94cm, or 8.5in x 11in) with 1" margins
- with page numbers, placed at the lower right hand corner of each page, beginning with the title page.

Case Reports may adapt either of the 2 formats:

1) Clinical Case Conference:

- Introduction based on Literature Review
- Initial Symptoms of the patient
- Family & Developmental History
- Pre morbid Medical History
- Initial Examination
- Treatment and course of Illness
- Discussion
- 2) Case Report:
 - Abstract
 - Introduction which includes a Literature Review
 - Case description in terms of history
 - Mental Status Exam
 - Diagnosis
 - Discussion of the case

The following must be included: an unstructured Abstract of a maximum of 100 words, brief Literature Review, description of the case, its treatment/management and discussion of analysis (psychodynamics)

and at least 10 references. Authors must protect patient anonymity and disguise their identifying information.

Commentaries may be up to a maximum of 1200 words, and include at least 10 references. Authors may be asked for source material to support factual statements in opinion pieces.

Book Reviews may be on books dealing with any topic or issue related to or of interest to psychiatry, psychology or mental health. Indicate book title, authors/ editors, city where it was published, year published, publisher, total number of pages and sale price of book reviewed. References are optional.

Letters are published at the editor's discretion and should not exceed 500 words, with at least 5 references. Letters related to material published in PJP may be sent to the author themselves for possible reply.
